- $d. \ All \ related \ expenses \ of \ the \ travel \ will \ be \ borne \ by \ herself;$
- e. If it is necessary to take extra leave in addition to the approved leave, the authority has to be informed through the concerned Embassy/High Commission as per the rules;
- f. The Provision of Rule 34 of Appendix VIII of BSR (Part-1) is applicable in this regard. That is to say, the officer has to start her leave within the 35 (thirty Five) days from the date of this order as this order will not remain in force after the 35 (thirty five) days from the making thereof and
- g. Travelling expenses will have to be shown in the income tax return.
- 2. During the holidays she will be assigned as an Officer on Special Duty (O.S.D) at the Directorate of Secondary and Higher Education (DSHE).
